Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 110 applicable to Service Classification Nos. 1, 2, and 3, and Delivery Adjustment Charge Statement No. 103 applicable to Service Classification Nos. 1, 2, 3, 5, 7, 8, and 9 of our Rate Schedule P.S.C. No. 8 – Gas. The Monthly Gas Supply Charge Statement No. 110 and the Delivery Adjustment Charge Statement No. 103 will be effective commencing with gas used on or after October 1, 2010.

The estimated amount related to surcharges and credits included in Statements No. 103 & 110 is \$1,354,000 based on estimated October 2010 sales of 17,920,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is an increase of \$379,100 on a monthly basis.

The surcharge calculation for October 2010 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.2 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.01920 /Mcf is applicable for October 1, 2010 through October 31, 2010.

The surcharge calculation for October 2010 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.1 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.00000 /Mcf is applicable for October 1, 2010 through October 31, 2010.

The Statement of Conservation Incentive Programs Cost Recovery has been updated to include rates effective October 1, 2010. These rates are pusuant to order in Case 07-M-0548 issused on June 24, 2010.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 160, Demand Transfer Recovery Rate Statement No. 155, Gas Transportation Statement No. 154, Natural Gas Vehicle Statement No. 160, Standby Sales Service Rate Statement No.160, Transportation Sales Service Rate Statement No. 162, Reserve Capacity Cost Statement No. 120, Weather Normalization Clause Multipliers Statement No. 103, Distributed Generation Statement No. 89, LIRA Minimum Charge Statement No. 64, Merchant Function Charge Statement No. 70, Incremental Monthly Gas Supply Charge Statement No. 66, Low Income Customer Affordability Assistance Program Statement No. 55, State Income Tax Credits Statement No. 35, Mandatory Upstream Transmission Capacity ("MUTC") Statement No. 18, Temporary State Assessment Charge ("TSA") Statement No. 16 and Conservation Incentive Programs Cost Recovery ("CIPs") Statement No. 7 are included.
