In accordance with General Information Section 42.E of P.S.C. No. 12 - Gas, the Statement listed below is filed to become effective August 1, 2010.

P.S.C. No. 12 - Gas

Statement of Revenue Decoupling Mechanism Adjustment RDM-1

Pursuant to the Order issued and effective June 22, 2009 in Case 08-G-0888, a Revenue Decoupling Mechanism ("RDM") was implemented for Central Hudson Gas & Electric Corporation ("Central Hudson" or "the Company") for gas Service Classification Nos. 1, 2, 6, 12 and 13 effective July 1, 2009.

As the first Annual RDM Period concluded on June 30, 2010, pursuant to General Information, Section 42.E, the Company is hereby filing RDM Adjustment factors to collect the delivery revenue shortfall for the period July 2009 through June 2010. This delivery revenue shortfall is the result of undercollection in all applicable service classes, and as a result, the Company is proposing to implement RDM Adjustment surcharges to become effect August 1, 2010.

In addition, a stipulation of the Commission in Case 08-G-0888 required the Company to track on a monthly basis the variance between equivalent customer months and actual reported customer months. The stipulation required the Company to investigate its standard methods of counting customers if the aforementioned variance was +/-0.5% on an annual basis, or +/-2.0% on a monthly basis. The Company notes that it did not exceed the established limits as presented in attachment A.
