Consolidated Edison Company of New York, Inc. ("Con Edison or the Company") hereby submits for filing with the New York State Public Service Commission (the "Commission") revisions to its Schedule for Gas Service, PSC No. 9 Gas (the "Gas Tariff").

The tariff leaves reflecting the revisions are identified below:

Leaf 183, Revision 11 Superseding Revision 10

Leaf 183.1, Revision 15 Superseding Revision 14

The leaves have an issue date of September 1, 2010, and an effective date of October 1, 2010

Reason for the Proposed Filing

Pursuant to the Commission's Order Approving Three New Energy Efficiency Portfolio Standard (EEPS) Programs and Enhancing Funding And Making Other Modifications For Other EEPS Programs, issued and effective June 24, 2010, in Cases 07-M-0548 and 09-G-0363 ("June 2010 Order") the Company is allowed to collect additional EEPS amounts through the System Benefits Charge ("SBC") of \$1,502,049 during the period October 1, 2010 through December 31, 2010 and \$3,031,182 for the year 2011. As a result, the revised total SBC targets are: for the year 2010, \$25,689,510, and for 2011, \$31,301,282. Targets for 2012, 2013 and 2014 will remain unchanged at \$906,238, \$409,426, and \$141,861, respectively.

Summary of Proposed Changes

In compliance with the June 2010 Order, Leaf Nos.183 and 183.1, Section IX.16, have been amended to include provisions to collect additional amounts through the SBC. In addition, a revised Statement of System Benefits Charge applicable to firm sales and firm transportation customers will be issued on September 1, 2010, to be effective October 1, 2010.

Conclusion

Pursuant to Ordering Clause 12 of the June 2010 Order, the Company is filing its tariff amendments and statement (apart from this filing) on not less than 30 days' notice to become effective on October 1, 2010. A Statement of System Benefits Charge will also be filed in December 2010, to be effective January 1, 2010 to reflect the additional SBC amounts to be collected during the year 2011. Furthermore, pursuant to Ordering Clause 12 of the June 2010 Order, the requirements of Section 66(12)(b) of the Public Service Law as to newspaper publication of the changes proposed by the tariff amendments have been waived.
