Effective: January 1, 2013

Purpose of Filing:

The purpose of this filing is to establish the SBC Factor No. 23, effective January 1, 2013 through December 31, 2013, in accordance with Rule No. 41-Adjustment of Charges Pursuant to the System Benefits Charge of PSC No. 220 Electricity.

1. <u>Case 05-M-0090-SBC III/Case 10-M-0457-SBC IV</u>

The Company is proposing the following SBC collection amounts for calendar year 2013:

- 1. SBC III \$26,997,658 in accordance with Order issued December 30, 2010 and
- 2. SBC IV \$20,559,021 in accordance with Order issued October 24, 2011
- 3. An under collection amount of \$1,962,803 for calendar year 2012

The total collection amount, per Attachment 1, Page 2 of 4, Line 13, including the under collection amount, is \$49,519,482 with a rate of adjustment of effective January 1, 2013 through December 31, 2013 of \$0.001775.

2. <u>Case 07-M-0548-Proceeding on Motion of the Commission Regarding an Energy</u> <u>Efficiency Portfolio Standard</u>

The Company is proposing the following SBC EEPS collection amounts for calendar year 2013.

- 1. \$67,553,115 In accordance with order issued October 25, 2011
- 2. \$2,626,156 In accordance with order issued October 23, 2009
- 3 \$164,166 In accordance with order issued January 4, 2010
- 4. An over collection amount of \$2,463,010 for calendar year 2012

The total collection amount, per Attachment 1, Page 3 of 4, Line 8, including the over collection amount, is \$67,880,427 with a rate of adjustment of effective January 1, 2013 through December 31, 2013 of \$0.002433.

3. <u>Total SBC III/SBCIV/EEPS SBC Collection Rate for January 1, 2013 through</u> <u>December 31, 2013</u>

The EEPS SBC incremental rate of adjustment of **\$0.002433/kWh** has been added to the SBC III/SBC IV Rate of Adjustment of **\$0.001775/kWh** to establish a total SBC total rate of adjustment of **\$0.004208/kWh** effective January 1, 2013.
