Dear Secretary Brilling:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") hereby submits for filing with the New York State Public Service Commission (the "Commission") the following tariff leaves reflecting revisions to its Schedule for Gas Service, P.S.C. No. 9 – Gas (the "Gas Tariff").

Leaf 177, Revision 10 Superseding Revision 9  
Leaf 178, Revision 11 Superseding Revision 10  
Leaf 178.1, Revision 5 Superseding Revision 4

These tariff leaves, which the Company is filing electronically today, are issued on 30 days' notice and leaves have an effective date of January 17, 2013. However the Company respectfully requests a limited waiver of Section 66(12)(b) of the Public Service Law so that the leaves filed today may become effective on short notice, on January 1, 2013.

#### **Reason for the Filing**

Pursuant to the March 15, 2012 Order in Case 10-G-0643 ("the Order"), the Company is filing revisions to its Gas Tariff to add a \$6.695 million per year component to the transportation surcharge included in the Load Following Charge component of the Monthly Rate Adjustment applicable to all firm customers.

### **Summary of Tariff Changes**

The following changes are being made to the General Information section of the Gas Tariff in compliance with the Order:

- Leaf 178 –The Load Following Charge section under General Information Section IX, Special Adjustments, is being revised to include, in the calculation of the Load Following Charge, an additional component in the transportation surcharge pursuant to the Order.
- Leaves 177 and 178.1 have been filed solely due to repagination of existing text.

### **Request for Waiver**

The Company respectfully requests a limited waiver of Section 66(12)(b) of the Public Service Law so that the leaves filed today may become effective on short notice, on January 1, 2013. The Company also requests a waiver of the requirements of §66(12)(b) of the Public Service Law respecting newspaper publication of the tariff changes being filed today that will permit the Company to complete the publication requirement within four weeks after January 1, 2013. The Company has conferred with Department of Public Service Staff and has been advised that Staff does not object to the Company's requests being addressed through a "One-Commissioner Order." Granting the requested waivers and allowing the tariff changes to be implemented on short notice will give effect to the Order as intended.
