Consolidated Edison Company of New York, Inc. (the "Company") hereby submits for filing with the New York State Public Service Commission (the "Commission") the following tariff leaves reflecting revisions to its Schedule for Gas Service, P.S.C. No. 9 – Gas (the "Gas Tariff").

The tariff leaves, which are identified below, are issued December 28, 2012 and are proposed to become effective on February 1, 2013:

Leaf 316.2, Revision 7 Superseding Revision 6 Leaf 316.3, Revision 4 Superseding Revision 3 Leaf 341.3, Revision 6 Superseding Revision 5

The Company is also issuing Supplement No. 45 to the Gas Tariff to cancel following leaves:

Leaf 316.2, Revision 5 Superseding Revision 4 Leaf 316.3, Revision 2 Superseding Revision 1 Leaf 341.3, Revision 4 Superseding Revision 3

Supplement No. 45 is proposed to become effective on January 28, 2013.

Reason for Filing and Changes Proposed

On July 2, 2012, the Company filed tariff amendments to implement a shut down option for interruptible gas customers in compliance with the Commission's "Order Directing Certain Utilities to Submit Tariff Amendments", issued May 23, 2012, in Case

No. 11-G-0543. The tariff amendments, including Leaf 316.2 Revision 5, Leaf 316.3 Revision 2, and Leaf 341.3 Revision 4, were proposed to become effective on August 1, 2012. The effective date of these tariff amendments was subsequently postponed to November 1, 2012.

On August 31, 2012, the Company made its Rate Year 3 compliance filing in Case No. 09-G-0795. The tariff amendments, including Leaf 316.2 Revision 6, Leaf 316.3 Revision 3, and Leaf 341.3 Revision 5, became effective on October 1, 2012.

In the instant filing, the Company is proposing housekeeping amendments to combine the changes made to Leaf Nos. 316.2, Leaf 316.3, and Leaf 341.3 in the above referenced filings.

Conclusion and Notice

Supplement No. 45 cancels the versions of the three tariff leaves that were filed on July 2, 2012. That supplement has a proposed effective date of January 28, 2013.

The revised versions of the tariff leaves have an issue date of December 28, 2012, and a proposed effective date of February 1, 2013.

The Company respectfully requests waiver of the Commission's requirement for newspaper publication, because these changes are of a housekeeping nature.
