RE: Case 11-M-0542, Excelsior Jobs Program and Cases 12-E-0008 and 09-E-0428, Rate Year 3 Electric Rates

Dear Secretary Brilling:

Consolidated Edison Company of New York, Inc. ("Con Edison" or the "Company") is filing with the New York State Public Service Commission (the "Commission") amendments to its Schedule for Electricity Service, PSC No. 10 – Electricity, applicable to its customers in the City of New York and the County of Westchester.

The Company is submitting the tariff leaves identified below to become effective on June 1, 2012:

Reason for Filing

On May 18, 2012, the Commission issued an Order approving the Company's tariff changes filed on February 29 and April 30, 2012, to implement the Excelsior Jobs Program ("EJP") in Case 11-M-0542, "In the Matter of the Commission's Implementation of Certain Provisions of the Excelsior Jobs Program" ("EJP Order"). The EJP Order approved the filings to become effective on June 1, 2012.

Two of the tariff leaves that were approved by the Commission's EJP Order – Leaf 351 Revision 2 and Leaf 446 Revision 2 - were revised subsequent to the Company's EJP filings. Updated versions of the leaves were filed on March 1, 2012, pursuant to Ordering Clause 5 of the Commission's <u>Order Establishing Three-year Electric Rate Plan</u>, issued and effective March 26, 2010 ("2010 Order"), in Cases 09-E-0428 and 08-M-0152. Those leaves were later canceled, and updated versions of the leaves were filed pursuant to the <u>Order Directing Use of Certain</u> <u>Credits to Offset \$133.5 Million Surcharge</u>, issued and effective March 22, 2012 ("2012 Order"),

in Cases 12-E-0008 and 09-E-0428. The changes to Leaf 351 and Leaf 446 are summarized below:

Leaf 351 (RDM): Revision 3, issued March 1, 2012, for Rate Year ("RY") 3 RDM targets in Case 09-E-0428, was subsequently canceled. Revision 4, issued March 29, 2012, in Cases 12-E-0008 and 09-E-0428, revised the RY 3 RDM targets and became effective April 1, 2012. Revision 4 was superseded by Revision 5. Revision 5, issued May 10, 2012, in Cases 12-E-0008 and 09-E-0428 further revised the RY 3 RDM targets and became effective May 11, 2012.

Leaf 446 (SC 9 maximum rate): Revision 3, issued March 1, 2012, for the RY 3 rate in Case 09-E-0428 was subsequently canceled. Revision 4, issued March 29, 2012, in Cases 12-E-0008 and 09-E-0428, revised the RY 3 rate and became effective April 1, 2012.

Tariff Changes

The Company is filing Leaf 351 Revision 6 to merge the text of Revision 2, approved by the EJP Order to become effective June 1, 2012, with that of Revision 5, which became effective May 11, 2012, pursuant to the 2012 Order. The Company is also filing Leaf 446 Revision 5 to merge the text of Revision 2, approved by the EJP Order to become effective June 1, 2012, with that of Revision 4, which became effective April 1, 2012, pursuant to the 2012 Order.

Conclusion and Notice

As directed by Ordering Clause 1 of the 2012 Order, the Company is filing these conforming tariff changes to take effect on a temporary basis on not less than one day's notice. The leaves have an effective date of June 1, 2012, the same date as the leaves approved by the EJP Order.

The Company requests waiver of newspaper publication, because the tariff changes are strictly of a housekeeping nature.

Pursuant to Ordering Clause 5 of the 2010 Order, the Company is serving copies of its filing to all active parties in this proceeding electronically and by first class mail.
