#### Overview

The Companies are proposing updates to its Table of Contents and section numbering within Schedules PSC No. 119, PSC No. 121, PSC No. 88 and PSC No. 90 to ensure the tariffs correctly reflect the sequence of provisions within the tariffs.

Furthermore, NYSEG is proposing changes to its tariff schedule, PSC No. 120, to incorporate tariff changes in compliance with a previously Commission approved filing in Case No. 11-E-0320 ("Net Metering Revisions") with the NYSEG's tariff filing submitted in compliance with the Commission's Notice to File Proposed Tariff Provisions, issued December 9, 2011 in Case No. 11-M-0542 ("Excelsior Revisions"). The revisions herein reflects the consolidation of these filings to ensure that previously approved Net Metering Revisions and Excelsior Revisions are appropriately reflected within the Company's tariff.

#### **Publication**

NYSEG requests waiver of publication of these proposed changes in accordance with Section 66(12)(b) of the Public Service Law, as these "housekeeping" revisions have no direct impact on the Companies' customers.
