Overview

In compliance with the Commission's Notice, the Companies previously submitted proposed Excelsior Jobs Program tariff rates for certain electric service classifications where the Companies have existing Empire Zone delivery rates. The instant filing is being submitted to propose additional changes after discussion with PSC Staff.

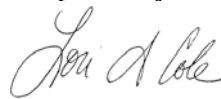
The Companies are proposing to clarify that the incremental load qualified for the Excelsior Jobs Program is exempt from the Revenue Decoupling Mechanism. Additionally, the Companies are proposing to clarify for natural gas customers qualifying for an incentive under the Excelsior Jobs Program and are weather-sensitive, their baseline usage will be weather-normalized. Furthermore, weather sensitive customers actual usage will be weather normalized to determine if a customer reaches its incremental threshold. NYSEG is also including changes to tariff leaves filed in compliance with the Notice that were also affected by a separate filing in compliance with another proceeding. These revisions are simply "housekeeping" changes.

Publication

The Companies respectfully request the requirements of Section 66(12)(b) of the Public Service Law regarding newspaper publication be waived as these changes will not affect the majority of the Companies' customers.
