Dear Secretary Brilling:

On February 6, 2012 new tariff leaves were issued and transmitted for filing on behalf of the City of Jamestown Board of Public Utilities and the Incorporated Village of Rockville Centre, in accordance with the requirements of the Public Service Commission. After discussions with the Department of Public Service Staff, we have revised the proposed tariff leaves for Rockville Centre and have proposed a new effective date of June 1, 2012 (rather than the earlier March 1, 2012 date) for both Rockville Centre and Jamestown's tariff leaves, in order to accommodate SAPA requirements.

Proposed tariff leaves for P.S.C. No. 7 Electricity (Jamestown Board of Public Utilities) and P.S.C. No. 4 Electricity (Village of Rockville Centre) for the purposes of establishing net metering tariffs to facilitate development of solar and wind generation. These tariffs are modeled after the Town of Massena and Village of Freeport tariffs that have been accepted by the Commission.

The municipalities' objectives are to stimulate the expansion of solar and wind generation within their communities. This action will produce positive energy and environmental benefits.

These revisions are issued as of February 16, 2012 and are proposed to be effective June 1, 2012.
