To PSC No. 214 Electricity

Effective: May 21, 2012

The purpose of this filing is to make minor revisions to PSC No. 214 Electricity to provide:

1. Further clarification to existing rules and service classifications;
2. Minor modifications and additions/deletions to existing rules and offerings;
3. Amendments to certain terminology, definitions and abbreviations, for example, adding definitions for 'high intensity discharge,' 'induction,' 'intra-account netting,' and 'low pressure sodium,' and removing the definition of 'service life.'
4. A definition and description of the backbilling rules, including the reference to the applicable regulation, to clarify the Company's obligation for the convenience of the customers;
5. Clarification on the application of Intra-Account Netting for the convenience of the customers;

6. The addition of a provision setting forth that the Company has no obligation to provide certain documentation beyond the statute of limitations when a customer requests such documentation related to billing discrepancies;
7. Standardization of 'Application for Service' throughout all Service Classifications;
8. Clarification regarding certain actions that may be taken when the Company is authorized to terminate services due to non-payment;
9. Inserting certain language from the Company's Electric Tariff, PSC No. 220 relating to Municipal Undergrounding for the convenience of customers;
10. Minor housekeeping revisions in text and format to existing leaves.

It should be noted that there will be no rate or bill impact on customers as a result of these proposed changes. Because of the numerous changes to the above leaves, redlined leaves are provided as Attachment 1 to this filing to show where the changes have occurred.

Waiver of newspaper advertising as required by §66(12)(b) of the Public Service Law is requested for this filing since the changes to the above leaves have no rate or bill impact on customers and are primarily for clarification purposes only.

The tariff leaves subject to revision in this filing are being submitted electronically with the Commission.
