Enclosed is an electronic version of Monthly Gas Supply Charge Statement No. 126 applicable to Service Classification Nos. 1, 2, and 3, and Delivery Adjustment Charge Statement No. 119 applicable to Service Classification Nos. 1, 2, 3, 5, 7, 8, and 9 of our Rate Schedule P.S.C. No. 8 – Gas. The Monthly Gas Supply Charge Statement No. 126 and the Delivery Adjustment Charge Statement No. 119 will be effective commencing with gas used on or after February 1, 2012.

The estimated amount related to surcharges and credits included in Statements No. 119 & 126 is \$2,179,000 based on estimated sales of 73,290,000 Ccf. The estimated effect on revenue, exclusive of surcharges and credits, is a decrease of \$1,656,900 on a monthly basis.

The surcharge calculation for February 2012 Intermediate Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.2 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.02220 /Mcf is applicable for February 1, 2012 through February 29, 2012.

The surcharge calculation for February 2012 Upstream Pipeline Stranded Capacity Surcharge pursuant to General Leaf No. 148.1 of P.S.C. No 8 – Gas results in a unit surcharge of \$0.00000 /Mcf is applicable for February 1, 2012 through February 29, 2012.

In addition, Deficiency Imbalance Sales Service Rate Statement No. 176, Demand Transfer Recovery Rate Statement No. 171, Gas Transportation Statement No. 170, Natural Gas Vehicle Statement No. 176, Standby Sales Service Rate Statement No. 176, Transportation Sales Service Rate Statement No. 178, Reserve Capacity Cost Statement No. 136, Weather Normalization Clause Multipliers Statement No. 119, Distributed Generation Statement No. 105, LIRA Minimum Charge Statement No. 80, Merchant Function Charge Statement No. 86, Incremental Monthly Gas Supply Charge Statement No. 82, Low Income Customer Affordability Assistance Program Statement No. 71, State Income Tax Credits Statement No. 51, Mandatory Upstream Transmission Capacity ("MUTC") Statement No. 34, Temporary State Assessment Charge ("TSA") Statement No. 32 and Conservation Incentive Programs Cost Recovery ("CIPs") Statement No.23 are included.
