To PSC No. 220 Electricity

Effective: December 1, 2011

On June 1, 2011, Chapter 35 of the Laws of 2011, amended Public Service Law (PSL) §66-j and §66-l in regards to the remote net metering of non-residential solar photovoltaic, farm waste, and farm and non-residential wind electric customer generators. To implement this law, the major utilities filed tariff amendments conforming their tariffs to these new statutory requirements to become effective December 1, 2011.

On November 21, 2011, the Commission issued its order in this case authorizing the tariff amendments listed in the order to become effective on a permanent basis, provided the electric utilities listed in the body of this Order file, by November 28, 2011, modifications as discussed in this order. These further modifications were directed to become effective on December 1, 2011.

Ordering clause No. 3 of this order also directed the electric utilities to comply with the revised Standardized Interconnection Requirements (SIR) and file revised SIR addenda to the tariffs to reflect the changes listed in the appendix by November 28, 2011 to also become effective December 1, 2011.

Per ordering clause No. 5 of this order, the requirements of 16 NYCRR §720-8 of the Commission's regulations as to newspaper publication is requested for this filing is waived for this filing.
