Effective: January 1, 2012

This filing is being submitted in compliance with the Commission's Order of January 24, 2011 which established new electric rates for Niagara Mohawk Power Corporation d/b/a/ National Grid ("Company"). In this order, the Commission directed the Company to file tariff revisions no later than July 31, 2011, to become effective January 1, 2012, to remove the Competitive Transition Charges ("CTC") from rates and establish a mechanism to recover certain deferral account balances. A detailed description of this filing is included in the separate filing and petition submitted to the Commission on this date.

Specifically, the above leaves remove the CTC from rates, establishes Rule No. 59-Temporary Deferral Recovery Surcharge, and updates base delivery rates to remove deferral recoveries from current rates. Rule No. 59 establishes factors for the recovery of the deferral account balances to be effective January 1, 2012 through March 31, 2013. Other minor modifications have been included in this filing to eliminate references to the CTC.

This filing respectfully submits these revised tariff leaves for filing in accordance with the Commission's directives for electronic filings.

Waiver of the requirements of Section §66(12)(b) of Public Service Law as to newspaper publication is requested for this filing since these requirements were completed with the original filing of in this case of January 29, 2010 and the compliance filing issued January 31, 2011.
