In accordance with Section 720-2 *et al.* of the Commission's Regulations, 16 NYCRR § 720-2 *et al.*, The Brooklyn Union Gas Company d/b/a National Grid NY ("Company") hereby submits the tariff leaves contained on Attachment A to become effective November 1, 2011.
