**Re: Case 08-E-0539, P.S.C. No. 10 – Electricity, Housekeeping Changes**

Dear Secretary Brilling:

Consolidated Edison Company of New York, Inc. (“Con Edison” or the “Company”) is filing with the New York State Public Service Commission (the “Commission”) amendments to its Schedule for Electricity, PSC No. 10 – Electricity (“P.S.C. No. 10”), applicable to its customers in the City of New York and the County of Westchester.

The P.S.C. No. 10 tariff leaves, which are identified below, are issued on not less than 30 days’ notice, to become effective on August 20, 2012:

**Background**

Pursuant to the Commission’s Order, “*Tariff filings by Consolidated Edison Company of New York, Inc. to replace its electric tariff schedules with electronic tariff schedules compatible with the Commission’s Electronic Tariff System,*” issued and effective February 16, 2012, in Case 08-E-0539, P.S.C. No. 10 became effective on February 20, 2012, merging and superseding P.S.C. No. 9 – Electricity (“P.S.C. No. 9”) and P.S.C. No. 2 – Retail Access. It has come to the Company’s attention that the Application for Service, Form A of P.S.C. No. 10, contains an outdated version of the Application for Service that once appeared in P.S.C. No. 9 but was later

revised, effective February 14, 2005, pursuant to the Commission's Order, S.P.O. 04-E-1337SP2, dated February 9, 2005, in Case 04-E-1337.<sup>1</sup>

### **Tariff Changes**

This current filing replaces the version of the Application for Service in P.S.C. No. 10 with the version of the Application for Service that was in effect in P.S.C. No. 9 at the time that rate schedule was replaced by P.S.C. No. 10. In addition, the Company is making the following minor housekeeping changes: (a) in the introductory section of the application form, on Leaf 366, the Company's telephone number for customers interested in steam service has been updated; and (b) in Part D, on Leaf 368, the names of the ST-120 and TP-385 exemption certificates in Part D have been revised to reflect the actual certificates' names.

### **Conclusion and Notice**

Because these changes are of a housekeeping nature, the Company is issuing this filing on not less than 30 days' notice, to become effective on August 20, 2012. The Company respectfully requests waiver of newspaper publication of these changes.

<sup>1</sup> Case 04-E-1337, "Tariff filing by Consolidated Edison Company of New York, Inc. to make revisions to its service application form for electric service and to make housekeeping changes." In that filing, the Company conformed item 7 of Part B of the Application for Service to that of the gas rate schedule and made minor wording changes. (For example, "telephone number" was changed to "contact information" in Part A, and "turned off" was changed to "discontinued" in Part C.)
